NOTIFICATION OF CHANGES TO THE ADDITIONAL CONDITIONS FOR THE IMPORTATION OF FROZEN CHICKEN INTO SABAH – THE USE OF STICKERS ON PACKAGING IS NOT PERMITTED

We refer to the above matter and our letter with ref. no. DVS(SKIE):100-44/25(114) dated 23th May 2025

02. Kindly be informed that an additional condition has been change, under which the use of stickers on the primary packaging of frozen chicken imported into the State of Sabah for displaying the required information is **no longer permitted. This condition shall be fully enforced with effect from 31 March 2026.**

03. Import licence applicants are required to upload images of the primary packaging, secondary packaging, and relevant labels at the time of application for the Department's reference. Applicants are responsible for ensuring that all frozen chicken imported into the State of Sabah complies with this requirement in accordance with the provisions of the Animal Enactment 2015.
