

**ADDITIONAL CONDITIONS TO IMPORT EDIBLE BIRD NEST (EBN) RAW
UNCLEAN FROM AVIAN INFLUENZA (NAI) FREE STATES IN PENINSULAR
MALAYSIA**

1. Veterinary Certificate from Veterinary Authority of *state origin* attesting that:
 - a. **State origin* is free of Avian Influenza (*Highly Pathogenic Avian Influenza-HPAI and Low Pathogenic Avian Influenza-LPAI*) and Salmonellosis; **and**
 - b. **The premise* is registered with Veterinary Authority and can be identified with Radio Frequency Identification Device (FRID); **and**
 - c.
 - i. The EBN originated from the premise(es) which have been accredited under **MyGAP** or **VHM** or **equivalent**; and is under regular health inspection supported with disease monitoring programme by veterinarian with relevant avian experience; **and**
 - ii. EBN were tested negative for Avian Influenza and Salmonella from either government or ISO accredited laboratories two (2) weeks prior to shipment. Laboratory result is valid per consignment only; **and**
 - iii. EBN were tested for the following Microbiology Test from either government or ISO accredited laboratories two (2) weeks prior to shipment. Laboratory result is valid per consignment only;
 - *E. coli* $\leq 1.0 \times 10^2$ cfu/g
 - *S. Enteritidis/S. Typhimurium/S. Gallinarum* not detected
 - Coagulative positive *S. Aureus* $\leq 2.5 \times 10^3$ cfu/g
 - *Listeria monocytogenes* not detected
 - And,**
 - iv. EBN were tested for the following heavy metals from either government or ISO accredited laboratories two (2) weeks prior to shipment. Laboratory result is valid per consignment only:
 - Lead (Pb) - $\leq 2\text{mg/kg}$
 - Arsenic (As) - $\leq 1\text{mg/kg}$
 - Mercury (Hg) - $\leq 1\text{mg/kg}$
 - Cadmium (Cd) - $\leq 1\text{mg/kg}$
2. Are transported in new clean containers.
3. On Arrival:

- a. A minimum of 20 gram of EBN shall be taken randomly at the point of arrival for HPAI/LPAI and microbes screening.
 - b. If the EBN which have been or is about to be imported is in the opinion of the State Veterinary Authority (SVA), infected with any disease stated in **1.a** or likely to have been in-contact with any infected or diseased animal or animal products, the SVA may at his discretion cause such EBN and any contact thereof to be destroyed at once at the expense of the importer.
4. The Director of Sabah Veterinary Services may at any time when deemed necessary suspend the importation of the products either temporarily or permanently in the event of disease outbreaks or suspected disease outbreaks or in case of importation in contravention of the above conditions.
 5. The Director of Sabah Veterinary Services reserves the right to amend the above conditions at any time as he may deem necessary.
 6. The confirmed time of arrival should be made known to the Animal Quarantine Office at **Kota Kinabalu International Airport Terminal 1 (KKIA T1), Tel: 088-413401 or 088-413400 (Fax)**, at least 2 days in advance.
